PESACH MESSAGE 5785

esach has always been a festival of paradoxes.

At one and the same time, the festival calls upon us to remember the suffering of our ancestors while slaves in Egypt, but also the joy of their liberation.

The Seder meal, which forms the centrepiece of the Yomtov, illustrates the inherent contradiction perfectly. We eat unleavened matza and bitter herbs, which symbolise our slavery, but we also sing jolly melodies, recline in regal fashion, drink wine or grape juice and dip foods, all of which represent our freedom.

Nothing encapsulates this apparent contradiction better than the hors d'oeuvres served at our tables – a hard-boiled egg in salt water.

The salt water represents our tears, while the egg sends out a profound message. Nearly

all other foods, when boiled, get softer. The egg, however, becomes harder. It reminds us that, when the heat is on in life, we can summon our inner resolve and stand firm. Therefore, in the very same dish, we combine pain and fortitude; desolation and hope.

I can hardly recall a Pesach when such mixed feelings are so prevalent. As I sit down to write this message, we are witnessing the extraordinary highs of hostages being returned to the loving embrace of their families and the agonising lows of discovering the depths of their suffering and the fate of those who tragically did not return alive.

Yet, in Jewish tradition, we never hesitate to highlight optimism and joy, even in the midst of our pain and sadness, nor do we shy away from recalling the deep traumas of our past at moments of great celebration.

For this reason, the saddest day on our calendar, Tisha Be'Av, is called Mo'ed – festival, by our Prophets, in anticipation of the day being transformed in the future to become the happiest of all days. Together with that, the Torah instructs us to celebrate all major Jewish festivals in memory of our exodus from Egypt and, at Jewish weddings, a glass is broken to remember the destruction of our Temples and all subsequent Jewish suffering.

We do this because it is from within the tragedies of our past that our resolve to build a better future is forged. The depths of our pain and the heights of our joy are therefore inextricably and permanently linked.

This is why, even with our ongoing deep anxiety about the welfare of the State of Israel and, indeed, for world Jewry, we will enthusiastically celebrate

From the Rabbi: A Pesach message "Stand By Me"

ne of the most telling statements in the Haggada is Vehi She'amda. The passage reads:

And it is this that has stood by our ancestors and us. For not just one alone [Pharaoh] has risen against us to destroy us, but in every generation they rise against us to destroy us – and the Holy One, Blessed be He, saves us from their hand!

What is meant by the opening words 'It is this that has stood by us'? What does 'this', refer to?

The obvious understanding is that it refers to the previous paragraph where we read. 'Blessed is He who keeps His promise to Israel.' The 'This' refers to Gd's promise to redeem the Children of Israel from the Egyptian exile and His ongoing promise to redeem us from all our exiles and persecutions. This promise has sustained the Jewish People throughout our long and tortuous history. We have always believed and trusted in G-ds promise that. in the end, it will all come riaht.

I have come across another, that the very fact of 'in every generation they rise against us to destroy us' is what has stood by us and given us the strength to persevere. Antisemitism and persecution have strengthened us and given us the fortitude to survive and flourish. I am not a fan of this insight which attributes something positive to the oldest hatred which embodies evil. It also seems to ignore, or minimise, the end of the passage 'the Holy One, Blessed be He, saves us from their hand.'

While this might not be an entirely accurate interpretation of the passage it does seem that, as repugnant as antisemitism may be, in a strange, perverse sort of way it may have contributed to the stubborn determination of Jews over many generations to identify Jewishly and stand up for their convictions. To live by the principles of our faith no matter what. I recently

learned of a teenager who, post-October Seventh, had been on the receiving end of antisemitism. His proud father told me that his son now wears a Kippa to school!

Another insight into Vehi She'amda is through Gematria – utilising the numerical value of the Hebrew letters. Vehi (and it is this) is spelt Vav, Hay,

Yud, Alef. The letter Vav has the value 6, Hay is 5, Yud is 10 and Alef is 1. It is our dedication to the Torah (both Oral and Written) embodied in the 6 Orders of the Mishneh and 5 Books of Moses, the Mitzvot represented by the 10 Commandments and our faith in the 1 G-d which has enabled us to survive. This is what has kept us strong and loyal, this is what has drawn down G-d's Divine protection.

The Festival of Our Freedom refers, not only, to the liberation from Egyptian slavery but also to our ongoing freedom and survival. A freedom granted to us so that we may be G-d's people. Let's reflect on this as we sing Vehi She'amda at our Seder.

Perla and I wish you all a very Happy and Kosher Pesach.

Why Ruth? Reflections on the festival of Shavuot

here are five Biblical Festivals (i.e. festivals mentioned explicitly in the Five Books of Moses): Rosh Hashana, Yom Kippur, Sukkot, Pesach and Shavuot. I remember hearing Chief Rabbi Jacobovits say that, of the five, Shavuot is the least observed and he posited the following reason; the other four are much more demanding. Rosh Hashana carries with it the solemnity of judgment and the introspection that it engenders. On Yom Kippur this is taken a stage further with a prohibition on eating, drinking and other physical pleasures. Sukkot involves the effort and expense of building a Sukka and procuring a Lulav and Etrog. Pesach, however beautiful a family occasion it may be, is a major upheaval.

But what happens on Shavuot? We eat cheesecake....not so stressful! Lord Jacobovits' contention was that we tend to appreciate what we invest more into. We do not value something which comes to us easily as much as something that requires effort and commitment. This observation was made in response to a gripe about the difficulty of preparing for Pesach.

Is Shavuot really that easy? Certainly its present-day observance is relatively stress free. Interestingly though, it celebrates an event which was extremely demanding.

We all like receiving gifts but the Torah. the most precious of G-d's gifts to us, was different. The Almighty was not prepared to part with it without great commitment on our part. The Rabbis tell us that He demanded guarantors and was not satisfied until the Israelites pledged their children; future generations that they would raise and educate in the ways of the Torah. They also made an unconditional commitment to keep the Torah's laws, saying that they would 'do' before they had even heard what that 'doing' entailed. This was true conviction on their part but it didn't finish with that generation. In the Ethics of the Fathers (chapter 6) we find the concept of Amailim Batorah - Toiling in the Torah - which will bring reward both in

this world and the world to come. There is a sense of the importance of effort; of earning as opposed to entitlement.

Why do we read the book of Ruth on Shavuot? The earliest reason given is that we are encouraged to emulate Ruth who 'acquired the Torah' - i.e. became Jewish – through great sacrifice and effort.

But is this all that there is to the Torah – commitment and effort? Didn't Hillel say 'That which is hateful to you do not do to your fellow. This is the whole Torah and the rest is commentary. Go learn!'? Didn't Rabbi Akiva comment on the verse 'love your fellow as yourself' – 'This is a great principle of the Torah'? Don't the Rabbis tell us that key Jewish characteristics are mercy, kindness and humility? Isn't it incumbent upon every Jewish community to provide for the needy? Isn't charity a primary Mitzva? Surely Judaism is a religion of kindness and compassion.

Maimonides lists eight levels of charity; the highest is to enable someone to provide for themselves. This doesn't mean that we shouldn't care for them until they are able to do so but it does mean that human dignity and self-respect are best served when we offer the opportunity for personal growth and self-sufficiency. This will likely require great effort on behalf of the beneficiaries but if they are prepared to make that effort and commitment then they are worthy of the gift conferred upon them.

There is a balance between the extremes of presumed self-entitlement and the harsh expectation that everyone stand on their own two feet; something that not everyone is able to do without assistance. The Torah was a gift, not something G-d had to give us but something He wanted to give us; not least because of our ancestors' commitment. Spiritually, if we 'invest' in the Torah with our energy and talent we will be rewarded with a true understanding and appreciation of Hashem's greatest gift.

I cannot thank Michelle Cooperman and Martyn Cooperman enough for their assistance with the computer arrangements of the shul. They have also given generously with their time, ably assisted by Naomi, their daughter, to the work of the Middle Street Brighton committee.

Thanks go to Howard Hamilton who has spent many hours assisting in restoring the structure of Middle Street and also who has recently won an arbitration award against our insurers thus making it possible to undertake further work

on the interior of the Synagogue. There is a separately Middle Street Synagogue application ongoing to the National Lottery for funding for the future of Middle Street. This is led by Michael Rosehill. So far we have reached the point of the financial proposals for the future use of the building, including the preservation of the Synagogue. The work has been undertaken to reach this stage of the application thanks to the

Purim was a great success. The shul was full on the first night of Purim and on the following day for the reading of the megillah.

We have held regular prayers for the hostages at all of our services and Rabbi Rader has attended many of the vigils at Palmeira Square Hove.

The Board would love more people to be involved with the shul either as members of the Board or as volunteers for other activities.

The Shul has adopted a safeguarding policy and I am pleased to advise that Eleanor Lind KC has become the person to whom any report of difficulties can be communicated.

We wish to offer more activities, and this does require more volunteers to come forward with various skills to facilitate this.

I have to thank also Michael Phillips and Russell Bloch for their work at the cemetery and the unsung chevra kadesha members who ensure that both male and female persons are buried with due deference to the requirements our shul. Also Penny Phillips who has stepped into any role which she was asked to assist

Our burial grounds are looking excellent and we have a very reliable caretaker living on site which is invaluable. I must thank my son Jonathan Conway for his sterling work at taking responsibility for the grounds.

Finally I must thank our treasurer Lindsay Davidson, who has put in many hours dealing with

History Old Levy, The Jew

compiled by Gordon Franks

he following article appeared in the Tuesday 11 November 1834 edition of the Morning Advertiser. It is reprinted verbatim.

From a correspondent.

The writer has chosen the above heading to this notice of two instances of longevity, who are still alive, as being the cognomen by which the old gentleman most familiarly known to the Citizens for nearly half a century; and, doubtless, many will be surprised to learn that the old man, who, twenty years ago was pointed out as a wonder in the streets, is still living, with his first wife; the ages of the patriarchal pair making together 200 years. He has completed his 105th, and she has completed her 94th year. The writer,

by accident, had the pleasure of seeing the venerable couple, and learnt the following particulars:-

vear." Joseph Levy is a native or Prague, the capital of Bohemia, where his father resided. and carried on the business of a horse-dealer, in which line he supplied the Duke of Bohemia. The subject of our brief memoir was born in the year 1729, and at the age of 14 was sent over to this country on account of his approaching the age when he might have been called upon to join the army as a conscript. This was about a year before the battle of Prague, which was fought in the year 1744. He commenced with the usual industry of his people to travel, and became an extensive hawker of iewellery. In the year 1756. he paid his addresses to a Jewess of Birmingham, whom he brought to

London, and married. She was then scarcely sixteen, and was a mother before she was seventeen years of age. She has given birth to twenty-five children, twenty-three of whom were living and two were still-born. She was fifty years and seven months when she gave birth to her youngest son, Abraham Levy. Of the children there are seventeen still living; the two first-born died in childhood; the others, who are deceased, had attained to mature years.

Old Levy, as he was familiarly called, was particularly well known in the country of Kent as a travelling dealer, and he travelled periodically throughout all England and Scotland; but his principal field of traffic was in Mark-lane

on the Corn-market, where he was as well known as the market itself, and his attendance there had far exceeded the recollection of the oldest frequenter of the market. He had for many years ceased to

travel; but until with the last four years he continued to follow his trade of hawking, when he walked about the city and suburbs with wonderful ease, supporting himself with a walking cane, and attended with a youth who carried his jewel-box. The writer has seen him about that time pursuing his avocation on the Surrey side, when he walked with a tolerably firm step, calling his wares for sale. When he finally retired from trade he gave up his connection on the Corn-market to his youngest son, Abraham, who now daily takes up his father's place with extensive and valuable cases of trinkets and iewellerv. Old Levy's reputation as a fair trader stood very high, and he had attained the confidence of the citizens particularly, and the other circles in which he dealt. He was never remarkable for abstemiousness, nor

did he ever indulge in intemperance; but at one time he associated much with sporting men, and was among the earliest backers of Mendoza, the boxer, who is also still living. He was particularly fond of snuff, and for many years used at least

a quarter of a pound per week. He was reputed as a man of hardihood, tall, and robust. In his youth highwaymen were common, and on that account he never went but armed with pistols. He computes that the litigation of a number of actions he was engaged in at law in his life time has cost him at least 10.000l... and he was the means.

we understand, the occupation rent free; and the parish officers, in consideration of his long residence and present circumstances, very handsomely excuse him his rates. His youngest son. Abraham, who had his business, makes his parents a weekly allowance, and altogether the aged pair are enabled to live comfortably, with a servant and a nurse as their attendants.

The old man's mental faculties are quite good, and his memory, as regards events and dates, wonderfully accurate, but his physical powers are much impaired: he cannot walk, yet his medical attendant declares his conviction, that, from all external symptoms, his constitution appears

so sound that he may add ten years more to his already long life. It is to be regretted that he had not been of those who wore beards, for he possesses an intelligent countenance, with strongly

Gordon Franks notes while the article is not relevant to Brighton it details a very remarkable life with no little affection.

It is not known if the writer was Jewish, he seems to know the East End community of the time well. What eventually happened to Mr Levy could be the subject of future research; however, such research may be difficult as there was no Jewish press then. If anyone has any information, please contact Gordon through the shul office.

Restoration of the Middle Street Synagogue moves forward

The Grade II* listed Middle Street Synagogue in the centre of Brighton is one of the City's most important buildings. It closed for regular services 20 years ago.

The Board of the Brighton & Hove Hebrew Congregation (BHHC), owners of the building, established a partnership with the Foundation for Jewish Heritage who were commissioned to carry out an assessment of the building and its future potential. The Foundation secured funding from The National Lottery Heritage Fund, the Architectural Heritage Fund and the Pilgrim Trust to carry out this work, and formed a Steering Committee to oversee the work chaired by Michael Rosehill.

The report that was produced called for the creation of a Jewish Cultural Centre within the synagogue that would bring the building back to life and provide a major new facility for the City.

The Foundation presented this proposal along with a Business Plan, which was approved by the BHHC Board. The Foundation is now moving to the next stage. This will include an application to the Heritage Fund to secure further funding to carry out detailed studies, leading to an application for a substantial grant to secure the future of the building, and provide it with a sustainable long term use.

Susan Conway, Chairman of the Congregation said "We are delighted that the Foundation has reached the point at which we can see a realistic prospect of our precious Middle Street Synagogue being put to good use for the benefit of the wider community, whilst at the same time being retained for occasional services, including weddings." She added "This year we will be celebrating the 150th Anniversary of the opening of the Synagogue in September 1875, and it is therefore particularly timely to know that we are moving forward with the restoration and future use of the building."

Michael Mail, Chief Executive of the Foundation, commented, 'We are very grateful to those who funded the initial reports, The National Lottery Heritage Fund, the Pilgrim Trust, and the Architectural Heritage Fund, and to the team who assisted with the initial research, conservation architects Purcell and heritage specialists Cultural Consulting Network. We are delighted that the findings have the support of the BHHC Board, and look forward to a a continuing dialogue with the Board and all those who have shown interest in this project, locally, nationally, and internationally. The stunning Middle Street synagogue is a hugely significant building and we must ensure its future in a meaningful way that will benefit the Jewish and wider community within Brighton and Hove and beyond.'

AAD commentaries

The Gaza Documentary

Action Against Discrimination ("AAD") is delighted to see and welcomes the BBC admission of, and apology for, the serious and unacceptable flaws in the making of the Gaza documentary and acknowledging that it should have carried out its own checks. It also notes with disgust and disapproval that the most senior news executive of the BBC watched the documentary before it was broadcast but failed to question it

AAD also welcomes the eventual intervention at long last of Ofcom, the BBC regulator, who has written an open letter to the BBC Chairman, accusing the BBC of undermining trust in its journalism and confirming the need for an investigation of these errors and the requirement to put in place systems to ensure that they cannot recur

AAD notes that Ofcom have said that they will, in exceptional circumstances, intervene to handle and resolve a complaint which has not been resolved by the BBC, and looks forward to learning of further developments in this regard.

The BBC Chairman and Director General will also be questioned at a parliamentary select committee on how the Gaza documentary was aired without disclaimers and full transparency, a move also fully welcomed by AAD.

Mr Metliss goes on to say that it is disappointing that the BBC has not corrected the flaws in its previous reporting on Gaza since 7 October 2023 and even earlier, and its deliberate anti-Israel bias and bigotry. AAD and Mr Metliss have maintained for some time that Ofcom should be intervening, addressing this anti-Israel prejudice and reporting which they have so far omitted to do.

AAD further welcomes the announcement by the Metropolitan Police that counterterror officers are looking into whether or not the law was broken in the making of the BBC documentary and to investigate claims of payments to the daughter of a Hamas official.

The applicability of the Rule of Law to the BBC is well overdue as is this latest

development involving the police The constant anti-Israel propaganda emanating from the BBC is arguably an incitement to racial hatred provoking antisemitism and antisemitic behaviour and it is about time that this was properly tackled and addressed by the relevant authorities, including the police.

AAD also equally and unequivocally condemns Channel 4 and Channel 4 News for the use in their Gaza coverage of the same teenager, the son of a Hamas official, who narrated the BBC documentary.

AAD calls on the Jewish Community, the Government and Ofcom to continue to exert further pressure on the BBC and Channel 4 to correct their inaccurate and misleading reporting on Gaza and Israel and for the Chairman and Director General of the BBC to resign from their respective posts.


